Zero tolerance of sexual abuse and sexual harassment; PREA coordinator

Auditor Overall Determination: Meets Standard

Auditor Discussion

The Fargo Residential Transitional Reentry Center (RTRC) for Males is privately operated by Centre Incorporated. The agency's PREA policy P-19 is titled Sexual Abuse/Assault/Harassment Prevention and Intervention and follows the guidelines of the PREA standards. Policy P-19 specifically states in the opening purpose paragraphs that Centre Inc. mandates zero tolerance towards all forms of sexual abuse. Policy P-19 outlines the agency's approach for preventing, detecting, and responding to sexual misconduct. There are additional policies that contain more specific information that relates to PREA such as policy P-18 Searches and policy P-23 Transgender Residents. However, policy P-19 is the main PREA policy. The PREA Coordinator holds the title as Director of Operations and has the authority to develop and oversee the efforts of the agency to prevent, detect, and respond to sexual abuse and sexual harassment. The Program Director is responsible for PREA compliance within the facility. Program Managers supervise Residential Staff who supervise the residents during the day-to-day activities on each unit. The two Program Managers assist in the day-to-day PREA related activities, are well-versed in PREA and are an integral part to ensuring PREA compliance. The PREA

Coordinator, the PREA Compliance Manager, and the Program Managers work well together as a team and ensure compliance is achieved and maintained with all PREA standards.

115.213 Supervision and monitoring

Auditor Overall Determination: Meets Standard

Auditor Discussion

Policy PE-34 Staffing Coverage outlines the staffing levels. The facility maintains a staffing binder that has all information regarding their staffing levels, analysis, and plan. The auditor reviewed the Fargo RTRC for Males PREA policies, organization chart, verified the staffing levels through the staffing plan, the staffing plan analysis, the schedule that was provided and verified through direct observation while on the facility tour and throughout the audit period. The South unit requires two (2) residential staff on shift from 6AM to 4PM, two (2) residential staff on shift from 4PM to 11PM and one (1) residential staff on shift from 11PM to 6AM. Often there is a third residential staff on-duty from 12PM to 8PM to cover the more staff intensive times of the day. The North unit requires three (3) residential staff on shift from 7AM to 3PM, four (4) residential staff on shift from 3PM to 11PM and two (2) residential staff on shift from 11PM to 7AM. There were no deviations from these minimum staffing levels noted during the audit reporting period. Managers require staff to stay on shift until properly relieved. If a staff calls in, there is an on-call supervisor who is responsible for finding a replacement staff or working the shift. The Fargo RTRC for Males has strong, consistent leadership, a good training program, and a positive culture. Upper-level staff including the Executive Director, the Director of Operations, the Program Director, and the Program Managers have an open-door policy, are available after business hours and fully support PREA and the mission to keep all residents safe. In addition to the residential supervisors that supervise the day-to-day activities of the residents, there are several Case Managers that assist residents in their treatment and reentry goals. There is a Licensed Addiction Counselor that provides counseling necessary for those with substance abuse issues. The facility reviews staffing and camera coverage annually and includes this information in the annual PREA Assessment report that is posted on the website.

115.215 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

The Fargo RTRC for Males policy P-18 Searches prohibits cross gender strip searches or cross-gender visual body cavity searches of residents. The policy requires two staff present during any pat search. All staff are properly trained in cross-gender pat search techniques. There must be probable cause for a strip search and it must be approved by the Executive Director. There are no female residents at this facility. Both female and male staff are on duty at this facility. However, only male staff perform pat searches. Female staff have been trained in cross-gender search techniques but would only perform a pat search in an exigent circumstance and there have been none. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex residents. If the resident's genital status is unknown, it is determined during conversations with the resident, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. All staff either stated or demonstrated to the auditor during the interviews that they use the blade or the back of the hand for a cross-gender pat search. This method of search is also used during all same-gender searches. The facility has policies and procedures and physical construction of housing areas that enable residents to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing them in state of undress. When female staff enter the housing unit of the male residents, they always knock on the door and make an announcement. This was verified by the auditor while on site and was consistently stated by all staff and all residents interviewed without exception.

115.216

Residents with disabilities and residents who are limited English proficient

Auditor Overall Determination: Meets Standard

Auditor Discussion

The Fargo RTRC for Males provides residents with disabilities and who are limited English proficient with ways in which to fully participate in protection efforts. The facility has a listing of interpreters to include sign language interpretation. The facility does not use residents to interpret for other residents. The facility is in compliance with the standard. However, their access to interpreters seems a bit cumbersome and may take longer than if they contracted with a pay-as-you go interpretive service that is able to provide an interpreter over the phone for most languages usually within minutes. The auditor recommends contracting with a 24-7 interpretation service that is easily accessible for staff. The interpretive services can assist in the intake process, screening process, education on how to report and if

need be, translate during the investigative process. Staff work with inmates who may have trouble reading or comprehension due to a disability or cognitive impairment. They read the information and explain it to them at a level they able to understand. These procedures were confirmed during staff interviews.

115.217 Hiring and promotion decisions

Auditor Overall Determination: Meets Standard

Auditor Discussion

The Fargo RTRC for Males currently requires during the hiring process that all interviewed staff answer questions regarding any previous sexual misconduct. These questions are asked again during the annual review process. Law enforcement background checks are run upon hire and every five years. This was confirmed by a review of employee files. The facility requires by the policy PE-9 Employee Standards of Conduct, Ethics, and Responsibility that should an employee be charged with, arrested for, or convicted of any felony or misdemeanor, that employee must immediately inform and provide a written report to the Executive Director. The staff are required to read and sign acknowledging this policy annually. The auditor recommended that a continuing duty to report statement be added to their sexual misconduct questionnaire forms that is used during the hiring process and the annual review process. In a review of the records, staff that had previous institutional employers did not always have reference checks that specifically ask previous institutional employers about any substantiated allegations of sexual abuse. The agency has a PREA Request for Information form to be used for this purpose, but it was not completed for two of the staff that met these criteria from the sample of employee records reviewed.

CORRECTIVE ACTION: To comply with this standard, the auditor required the Fargo RTRC for Males provide the auditor documentation of asking former institutional employers about substantiated sexual misconduct for those that were missing. On May 25, 2023, the PREA Coordinator provided the requested documentation. In addition, the Human Resource Generalist began an update of the personnel files agency-wide to include a PREA specific tab. Previously, PREA Release of Information forms were filed in a "Miscellaneous" tab which made it difficult to track to ensure compliance. Going forward, the Human Resource Generalist will remind all statewide Program Directors and Program Managers to ensure PREA Release of Information forms are completed during the applicant's fingerprint processing. This reminder will be delivered twice per year during monthly department meetings beginning June 2023.

115.218 Upgrades to facilities and technology

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed the Fargo RTRC for Males policy, video monitoring systems, directly observed the facility and conducted interviews with the Executive Director, the Program Director, the Program Managers and the PREA Coordinator. The facility considers protection of residents and the standards when contemplating upgrades to the facility or in the application of technology. The facility has not completed any major upgrades to either building or monitoring technology since the last audit.

115.221 Evidence protocol and forensic medical examinations

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed the PREA policy and interviewed the investigators, both administrative and criminal, assigned to conduct investigations. Residents who have been sexually assaulted would be transported to Sanford Health or Essentia Health. There are SANE nurses at the hospitals to conduct the forensic examination. Rape and Abuse Crisis Center provides advocacy services. Evidence protocol is followed both at the facility and through the collection during the forensic examination. The center staff work cooperatively with either the Fargo Police Department or the Cass County Sheriff's Department, and the SANE to ensure all usable physical evidence is gathered. The auditor verified these procedures through interviews and a review of policy.

115.222 Policies to ensure referrals of allegations for investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

The facility refers all allegations for investigation. A trained investigator completes preliminary administrative investigations. Both the PREA Coordinator and the Program* Director as well other key staff have been trained to conduct administrative investigations. Any incident that is suspected to be criminal is referred to the either the Fargo Police Department or the Cass County Sheriff's Department to conduct any criminal investigation. The investigative policy is contained in section II.D of the PREA policy P-19 which is published on the Center Inc. website at https://www.centreinc.org/prea

115.231	Employee training
	Auditor Overall Determination: Meets Standard

	The PREA policy P-19 section II.H. governs the facility's training procedures. The Fargo RTRC for Males uses an online learning management system "Relias" to provide employees on-going PREA training. Staff were knowledgeable in the required competencies such as the characteristics of vulnerable residents, avoiding inappropriate relationships, detecting signs of sexual abuse, correct first responder response – separate, provide care, protect evidence, call for assistance, notify the Program Manager and the on-call duty supervisor, and provide a written report. They watch the video "PREA: What You Need to Know" (Joe) and participate in an online training developed by Relias titled "the Dynamics of Sexual Abuse in Confinement".

115.232	Volunteer and contractor training

	This facility had one volunteer that completed the PREA Acknowledgment training/ education form. The only contractors are information technology (IT) contractors who may have some very limited access to residents. The IT contractors have completed some basic PREA training on the facility's zero tolerance policy and how to report. They signed forms acknowledging this training and it was verified by the auditor by viewing this documentation and in an interview with one of the IT contractors.

115.233	Resident education

	Auditor Discussion
	The Fargo RTRC for Males provides extensive PREA information to a resident during the intake process. This information includes their zero-tolerance policy and how to report. During the initial intake process the residential staff goes over the intake packet with them. The intake process includes viewing the video PREA: What You Need to Know, staff going over a PREA information packet with them and pointing out the posters that are located throughout the facility that have reporting information and support and contact information for the Rape and Abuse Crisis Center that can provide support services that can assist victims in their recovery

process. The residents signed a form acknowledging that they received the Overview for Clients on Sexual Abuse/Assault Prevention and Intervention.

Staff were aware that there is a list of interpreters available if a resident does not speak or understand English or uses sign language to communicate. Staff will read the material aloud to residents who may need assistance due to visual impairments, learning disabilities, literacy or comprehension problems or other reasons that require staff to give them specialized training for them to be better able to comprehend the information.

There is readily available information posted throughout the facility that outlines how to report and how to contact external resources for both support and reporting. The residents' education was evident by the residents' responses during the interviews. Compliance with this standard was verified through a review of the resident education materials, the signature sheets, interviews with residents and interviews with staff.

115.234 Specialized training: Investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

The investigators for the Fargo RTRC for Males have received specialized training as facility administrative investigators through the North Dakota Department of Corrections and Rehabilitation (ND DOCR) course Investigating Sexual Abuse in a Correctional Setting. The auditor interviewed the PREA Coordinator who has also been trained as an administrative investigator and found him to be well trained meeting all the requirements of the standard. In addition, the auditor interviewed the Sergeant with the Fargo Police Department who either would be assigned or assign another detective sexual assault cases for the Fargo Center Inc. male and female facilities. He stated that sexual abuse investigators are trained as all detectives with basic criminal investigations training as well more specific training in sexual assault investigations to include interviewing sexual abuse victims, Miranda and Garrity warnings, evidence collection and are aware of the criteria to substantiate a case for used by the facility for an administrative investigation and for prosecution referral. These interviews and a review of training documentation demonstrated compliance with this standard.

115.235	Specialized training: Medical and mental health care	
	Auditor Overall Determination: Meets Standard	
	Auditor Discussion	

There are no full or part-time medical or mental health care practitioners who work within the Fargo RTRC for Males. The resident chooses their private provider from those available within the community. Typically, Sanford Health, Essentia Health, North Dakota Health and Human Services or private physicians or therapists provide these services. These facilities are also utilized by the facility in the event of a crisis or emergency situation.

115.241	Screening for risk of victimization and abusiveness
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Fargo RTRC for Males completes a screening process upon intake. The screening form has the appropriate questions as required by the standard to objectively screen each resident upon arrival. Staff confirmed that they are continually reassessing a resident's status. The residents meet their case manager within 72 hours of arrival, and they are reassessed. They specifically would reassess if any staff made a referral or request, or if there was an incident of sexual abuse or receipt of additional information that has bearing on their risk of sexual victimization or abusiveness. Information is maintained within a protected directory. Staff are required to follow a confidentiality agreement.

Auditor Overall Determination: Meets Standard Auditor Discussion The Fargo RTRC for Males screening process is used to determine placement within their housing areas. There are enough housing options to keep separate if the screening indicated this was necessary. All housing assignments are done on a case-by-case basis considering the resident's own views of safety. Residents on the north unit have a private restroom with a shower, sink, toilet and locking doors for privacy that is shared between two sleeping rooms. The north wing has a group restroom, but each toilet stall has a door, and each shower stall has a curtain for privacy. Residents who indicate they are transgender, or intersex may be either assigned to the north wing that has private restrooms or if on the south wing may be asked if they wish to shower after 11pm when other residents are required to be in their rooms. This information is recorded on a form and staff are aware.

115.251 Resident reporting

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor interviewed staff and residents, reviewed policy and toured the facility. The Fargo RTRC for Males provides multiple internal ways for residents to privately report sexual abuse and sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents. Staff accepts reports made verbally, in writing through grievances or notes to the administrator, anonymously, and from third parties. The staff promptly documents any verbal reports. All residents have unrestricted access to phones in the dining hall. Residents are provided the address to the NDDOCR PREA Coordinator and Bureau of Prisons (BOP) residents are provided the phone number and address to the Regional Residential Reentry Manager. The auditor tested these systems. Both indicated they accept anonymous reporting, and they would immediately report back to the administrator of the Fargo RTRC for Males any reports of sexual abuse and sexual harassment. The residents can request postage and give their letters to any staff or mail them in the community while they are out of the building. Most residents have cell phones and there is a bank of phones in each wing's dining hall. The call is a free call and is not recorded. There are a few ND DOCR placed residents whose one external reporting option is to send a letter to the ND DOCR, yet they are unable to leave the building. To protect the anonymity of these residents if they wish to report anonymously, the auditor recommends that they develop a way to post a free letter without having to ask staff. These processes, phone numbers and addresses are provided to the resident during the intake process and are located on posters throughout the building.

CORRECTIVE ACTION: The auditor required that the facility develop a method for ND DOCR referred residents to be able to mail a letter to the ND DOCR PREA Coordinator, an external reporting entity for these residents, in a manner that is free and allows them to remain anonymous. Centre Inc. developed new language for their PREA Reporting Posters that states, "Upon request at any time, staff will provide a blank envelope with postage to all residents. Staff will not inquire about the purpose of this request. This is at no cost to the resident".

115.252 Exhaustion of administrative remedies

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed the Policy P-7 Grievance/Administrative Remedy regarding using the grievance system to report an allegation of sexual abuse, the handbook, and conducted staff and resident interviews. The policy section regarding administrative remedies mirrors the wording of Standard 115.252. The Fargo RTRC

for Males does not impose a time limit on when a resident may submit a grievance regarding an allegation of sexual abuse. They do not require a resident to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse. They ensure that a resident who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint. They issue a final decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance.

The policy does not allow residents to submit grievances for other residents in other types of grievances but does for an incident alleging sexual abuse. Policy P-7 has the words verbatim from the standard with regard to using the grievance process to report an allegation of sexual abuse. Third parties, including fellow residents, staff members, family members, attorneys, and outside advocates, are permitted to assist residents in filing requests for grievances relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of residents. They have established procedures for the filing of an emergency grievance when the resident is subject to a substantial risk of imminent sexual abuse.

After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the grievance is immediately forwarded to the Administrator for immediate corrective action and provides an initial response within 48 hours and issues a final decision within five calendar days. The initial response and final decision documents their determination whether the resident is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. The Fargo RTRC for Males may discipline a resident for filing a grievance related to alleged sexual abuse only where the administrator demonstrates that the resident filed the grievance in bad faith.

115.253 Resident access to outside confidential support services

Auditor Overall Determination: Meets Standard

Auditor Discussion

The Fargo RTRC for Males has a Memorandum of Understanding with the Rape and Abuse Crisis Center (RACC) Fargo to provide confidential support services. Residents are provided information regarding outside confidential support services during the intake process. They are given a handbook with this information to refer to throughout their stay. There are posters posted throughout the facility with the address and phone number to the RACC for advocacy and support services. The auditor spoke with a counselor from RACC using a resident phone and the phone number on the poster near the phone and therefore verified that it was a free call and that they would provide both emotional support services and advocacy services to any resident who calls. The auditor also spoke with the director of RAAC who stated that they have worked with Centre residents in the past and the facility does work cooperatively with them to ensure residents obtain the services they need in a confidential manner.

115.254	Third party reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility has Third Party Reporting information in their policy, the reporting information is posted throughout the facility, and in the resident handbook given at intake. There is contact information on their website at https://www.centreinc.org/prea that can be used by third parties for PREA reporting.

115.261	Staff and agency reporting duties
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility requires by their PREA policy that all staff are to immediately report any knowledge, suspicion or information received related to sexual abuse/harassment incidents, retaliation and staff negligence that may have contributed to such incidents. There are no on-site medical or mental health staff. There are no residents under 18 years of age. If the alleged victim is considered a dependent adult under State law, the facility will report the allegation to the Department of Health and Human Services under applicable mandatory reporting laws. Staff are required to make any reports to the supervisor or on-call management staff. Any verbal reports are followed by a written PREA Incident Report form that is submitted to the Program Director and the PREA Coordinator. The PREA Coordinator then assigns an investigator. Staff interviews confirmed their responsibility to report and to maintain that information in confidence. The PREA policy requires that an investigator is assigned to all allegations of sexual abuse and sexual harassment. All staff during interviews stated that they would report directly to the Fargo Police Department if the situation warranted.

115.262	Agency protection duties

	The facility requires all staff to take immediate action to protect the resident from imminent sexual abuse. All staff understand that "immediate" means when the response is needed – that could mean within minutes if the abuse was recent, or it could mean before the end of the shift for incidents in which an abuse was reported that occurred in the distant past.

115.263	Reporting to other confinement facilities

	Interviews with staff confirm that action is taken upon receiving an allegation of sexual abuse while a resident was at another facility. Such action is initiated no later than 72 hours and actions are documented. These steps were also noted in the review of the policy. Incidents will be reported to the Resident Manager so that it can be reported to the head of the facility in which the abuse may have occurred. There was one reported incident during this audit reporting period. There was documentation to verify that it was reported to that facility as required per the standard.

The facility has posted coordinated response plans throughout their facility and many staff referenced them during discussions on the facility coordinated response plan. The coordinated response plan documents the coordinated actions among first responders, investigators, facility administrators, victim's centers, health care providers and law enforcement. The interviews with the Resident Director, Resident Managers, the PREA Coordinator, the center staff, the Rape and Abuse Crisis Center, the SANE program at Sanford Health, and the Fargo Police Department verified the actions outlined within the policy. Once the administrator or the Fargo Police Department are notified, the coordinated response includes the individual being taken to the hospital for a forensic examination when applicable, an advocate is provided from

Rape and Abuse Crisis Center for emotional support services and the investigator is notified so that the victim does not have to portray the circumstances of the assault repeatedly to multiple people.

Investigations will not be terminated due to the departure of an alleged abuser or victim. These steps are properly documented in the PREA Policy under the investigation section. The investigations include efforts to determine whether staff actions/failures contributed to the abuse documented through written reports, which will include physical/testimonial evidence, credibility assessments and investigative facts and findings. The Program Director, Program Managers and the PREA Coordinator are trained administrative investigators. Criminal investigations will be conducted by a trained investigator from either the Fargo Police Department or the Cass County Sheriff's Department.

Termination is the presumptive disciplinary sanction for staff that have engaged in sexual abuse.

Disciplinary sanctions for violations of agency policies relating to sexual abuse or sexual harassment (other than engaging in sexual abuse) are commensurate with the nature and circumstances of the acts committed, the staff member's disciplinary history, and the sanctions imposed for comparable offenses by other staff with similar histories.

All terminations for violations of agency sexual abuse or sexual harassment policies, or resignations by staff that would have been terminated, if not for their resignation, are reported to the Fargo Police Department, unless the activity was clearly not criminal. There have been no staff terminations during this audit reporting period due to either sexual harassment or failure to properly supervise or enforce the rules, which resulted in sexual misconduct between residents.

Auditor Discussion

The auditor interviewed the Program Director, the Program Managers and the PREA Coordinator and reviewed the policy. This facility currently is not using volunteers. The only contractors are from the information technology (IT) company that provides their IT services. Volunteers and contractors are subject to disciplinary actions including termination of services for violation of facility sexual abuse/ harassment policies. According to the Executive Director and the Program Director, should any violation of this type be substantiated, the facility has complete authority to administer remedial measures including prohibiting further contact with residents. Contractors or volunteers who engage in sexual abuse will be reported to the Fargo Police Department (unless the activity was clearly not criminal). These requirements are outlined in their policy.

The auditor interviewed staff and reviewed policy. The facility prohibits disciplinary action for a report of sexual abuse made in good faith based upon a reasonable belief that the alleged conduct occurred. The agency does not offer therapy, counseling or other interventions designed to address and correct underlying reasons or motivations for the abuse. If findings of resident-on-resident sexual abuse are substantiated, administrative sanctions will be administered following the formal disciplinary processes and applied commensurate with the level of infractions. Some examples given are loss of privileges. More serious infractions would be transferal to another more secure facility and additional criminal charges.

Auditor Overall Determination: Meets Standard Auditor Discussion The auditor interviewed staff and reviewed policy. All medical and mental health services are performed through community medical and/or mental health services. Medical and mental health services are typically provided by Sanford Health, Essentia Health, North Dakota Health and Human Services or private physicians or therapists. Staff as first responders are aware of their duty to immediately notify the appropriate medical and mental health practitioners. Emergency medical and mental health services are provided without charge to residents and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident. Continuing services are determined by community medical and behavioral health practitioners according to their professional judgment.

Ongoing medical and mental health care for sexual abuse victims 115.283 and abusers Auditor Overall Determination: Meets Standard **Auditor Discussion** The auditor interviewed staff and reviewed the PREA policy. Centre offers access to medical and mental health evaluations and treatment to all residents who have been victimized by sexual abuse in any prison, jail, or lockup through referrals to community based medical and mental health facilities and practitioners, as appropriate. The evaluation and treatment will include follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from the center. Victims of sexual abuse are offered tests for sexually transmitted infections as medically appropriate as determined by community health providers. The Fargo RTRC for Males will attempt to obtain a mental health evaluation of resident-on-resident abusers within 60 days of learning of such abuse history and offer treatment within the community

when deemed appropriate by mental health practitioners.
