## AUDIT FINDINGS

### **Narrative:**

The PREA audit of Centre Inc. - Mandan was conducted on July 25-26, 2017 by Andrasca Consulting LLC / Dave Andrasca, PREA certified auditor. This is the second PREA audit for this facility. Prior to the on-site audit, contact was made with the PREA Coordinator regarding logistics and checking on the posting of notices. The PREA Online Audit System (OAS) was used to complete the audit. The PREA Pre-Audit Questionnaire was completed on line by the PREA Coordinator/Director of Operations and supporting documents were uploaded in the OAS. The auditor reviewed and evaluated the information provided by the facility as well as the Centre Inc. website prior to the audit. The auditor utilized the online Auditor Compliance tool.

The audit began on Tuesday morning July 25, 2017 with an entry meeting with the Director of Operations/PREA Coordinator, Quality Control Manager, Clinical Program Manager/ PREA Compliance Officer, Residential Program Manager and key staff. The staff introduced themselves and provides a brief overview of their areas of responsibilities. The auditor introduced himself and provided his background and discussed the audit process. A tour of the facility was completed. All required facility staff and residents interviews were conducted on-site during the two day audit.

On the first day of the audit there were 28 female residents and 45 male residents for a total of 73 residents. Fifteen residents (5 female and 10 males) were interviewed (20% of the 73 residents). The residents interviewed were selected by the auditor from the housing rosters and designated lists of residents provided by the facility. Of the residents interviewed , one was self-identified as Lesbian, Gay, Bisexual, Transgender or intersect (LGBTI) and one had previously reported sexual abuse. There were no disabled or limited English Speaking residents at the facility during the audit.

A total of eleven (11) staff that worked at the facility was formally interviewed during the audit (55% of 21 staff). Three staff that work at the agency's administrative office were also interviewed. Random Staff were selected from each of the three shift rosters and different departments within the facility. Additionally, specialized staff were interviewed including the Executive Director (Telephone interview), Director of Operations/PREA Coordinator, PREA Compliance Officer, Intermediate- Higher Level Staff, Staff Who Perform Screening, Incident Review Team, Staff Who Monitor Retaliation, Human Resource Generalist (telephone interview) and Intake staff.

In addition to these formal interviews, many informal discussions were held with staff and residents which assisted in this PREA compliance audit. No residents contacted the auditor, prior or after the audit, or requested to meet with the auditor while on site.

There were five allegations of sexual abuse or sexual harassment reported in the past twelve months at Centre Inc. Mandan. All five allegations were investigated. A review of the investigations and SARTs was conducted. Two allegations of sexual harassment were substantiated, one allegation of sexual

harassment was unsubstantiated, one allegation of sexual abuse was unsubstantiated and one allegation of sexual abuse was unfounded.

An exit meeting was conducted by the auditor David Andraska at the completion of the on-site audit. While the auditor could not give the facility a final finding, the auditor did provide a preliminary status of their findings and indicated further analysis of documentation will be required. Staff morale appeared to be good and the observed staff and resident interactions were appropriate. There were no "blind spots" observed during the tours and adequate video cameras supplement the staff monitoring of residents. Staff was knowledgeable of the PREA standards and were courteous, professional and cooperative. The auditor commented on the PREA orientation for the resident and that staff take the time to verbally explain the process to the residents to ensure they understand their rights. The auditor thanked the PREA Coordinator, Directors and facility staff for their hard work and commitment to the Prison Rape Elimination Act.

## AUDIT FINDINGS

### Facility Characteristics:

Centre, Inc. is a North Dakota private non-profit rehabilitative, correctional and human service agency which was formed in 1976 to assist the courts and other mainstream public agencies in providing community-based services to establish halfway houses as a cost-effective intermediate sanction as well as an adjunct to parole or probation supervision. CENTRE: is an Acronym with the legal name being "Community Extended Nuclear Transitional Residence for Ex-offenders". Headquartered in Fargo, ND, Centre's programs and clients have greatly grown in numbers and its programming has evolved since its inception and currently has facilities in Fargo, Mandan and Grand Forks. The role of Centre, Inc. has been to provide for public safety by offering programs across the state which can effectively rehabilitate, supervise, and provide transitional housing to individuals in need of these services outside the institutions and jails/prisons.

Centre, Inc. has agency wide policies and procedures that apply to all programs. Centre Inc. maintains a website at <http://centreinc.org/> with a PREA section that lists reports, policies and relevant information. Centre, Inc. should be commended for their efforts to implement practices that show a commitment and understanding of the spirit and intent of the Prison Rape Elimination Act.

This PREA audit is for the Centre Inc. - Mandan Residential Program in Mandan, ND. The Facility is located at 100 6th Avenue SE, Mandan, ND in a neighborhood that is a mix of residential and commercial properties. The facility has a tall wooden privacy fence surrounding the property. The facility is a one-story cinderblock constructed building that was renovated for this program in 2008. The building has two distinct programs (male and female) with separate main entrances for each program. Each entrance leads to a small control center where visitors sign in/out and program residents sign in and out for each of their daily activities. The facility has surveillance cameras throughout and are monitored from the respective control centers.

On the female side there are 4 sleeping rooms which have a total of 28 female beds. On the male unit there are ten sleeping rooms which have a total of 48 male beds. The facility has a total of 76 beds. There is one main kitchen with separate dining rooms for male and female residents. Each side has a dayroom, control center, program space and staff offices.

The program houses residents from the U. S. District Courts including U. S. Probation, Federal Bureau of Prisons, and the North Dakota Department of Corrections and Rehabilitation and custody level includes Inmate, Parole, Probation and Pre-Trial. Centre's residential services provide a supportive and structured living environment in which general counseling, drug testing, intensive monitoring, and chemical dependency and other treatment services are provided to adults who can benefit from a cognitive behavioral approach. The transitional residential facilities are staffed on a twenty-four hour a day basis. Although most residents are allowed to leave the facility for work and programming purposes, they must sign out and in with staff approval prior to leaving and upon return. Depending on varied referral source parameters and/or level/phase systems, residents may also sign out for other purposes.

Centre Inc. Mission Statement “Centre Inc. is a private non-profit agency that provides rehabilitative services to individuals to achieve social re-integration. Centre's Core Values: Integrity, Safety/Security, Empowerment, Compassion”



## AUDIT FINDINGS

The Centre Inc. -Mandan, was assessed as "In Compliance" with the PREA standards in this Final Report. As listed above, of the 41 standards for Community Confinement Facilities, three (3) standards were assessed as substantially exceeding the requirements of the standard. Thirty Eight (38) standards were assessed as meeting substantial compliance in all material ways with the standard for the relevant review period. (Please note that, standards that did not apply such as 115.212 Contracting with Other Entities, where there are no contracts with other entities; 115.235 Specialized Training: Medical and Mental health care, no medical or mental health care staff employed or contracted; and standard 115.266 Preservation of Ability to Protect Inmates from Contact with Abusers, when there are no collective bargaining agreements; such standards were described as meeting the standard and were marked as "meet standards").

	<b>Auditor Discussion</b>
	<p>Centre Inc. written policy #P-18 Sexual Abuse/Assault Prevention and Intervention addresses the requirement of this standard. The Policy mandates zero tolerance toward all forms of sexual abuse and sexual harassment and outlines the agency's approach to preventing, detecting, and responding to such conduct. This policy, on Centre Inc.'s website as well, is the basis for creating a zero tolerance culture in regards to all forms of sexual abuse and sexual harassment. Centre Inc. - Mandan demonstrates a commitment to safety for residents and staff, while supporting a culture of prevention, detection, reporting, and response. Staff interviews revealed an ownership of the agency's commitment to the prevention, detection and response to sexual abuse and sexual harassment, and were well versed in this policy.</p> <p>Centre Inc. employs an upper-level, agency-wide PREA Coordinator. The PREA Coordinator is based in Fargo, ND, and is proactive and committed to the implementation and enforcement of all PREA standards. The PREA Coordinator is also the Director of Operations and supervises the PREA Compliance Officers at each site. The PREA Compliance Officer for Centre Inc. - Mandan is also the Program Director. Interviews with the PREA Coordinator and PREA Compliance Officer revealed both acknowledging sufficient time and authority to develop, implement, and oversee efforts to comply with the PREA standards. The PREA Coordinator/Director of Operations and the PREA Compliance Officer/Program Director are evident on the agency's organizational chart, Centre, Inc. Policy #PE-1.</p> <p>Through review of policy, observation of bulletin boards, posters, handouts and materials, review of resident and staff handbooks, training curriculums and interviews with staff and residents it was apparent that Centre Inc. - Mandan is committed to zero tolerance of sexual abuse and sexual harassment and exceeds the requirement for Standard 115.211.</p>

	<p>This standard is Non-applicable, Centre Inc.-Mandan does not contract for the confinement of its resident. Centre Inc. is not a public agency, It is a private non-profit that provides services through contract with state and federal agencies for confinement of their residents.</p>

	<p>Centre Inc. policy #PE-34 Personnel addresses the facility's staffing requirement. Centre, Inc. has developed a staffing plan for Centre Inc. -Mandan that is based on the four criteria of this standard to include (1) The physical layout of each facility; (2) The composition of the resident population; (3) The prevalence of substantiated and unsubstantiated incidents of sexual abuse; and (4) Any other relevant factors. The current staff plan and PREA assessment was completed on February 9, 2017. Based on the review of the staffing plan and interviews, the staffing plan was developed by the Director of Operations/ PREA Coordinator with input from facility management staff. The facility does not deviate from the approved staffing plan. The staffing plan is reviewed annually and is supported by agency policy.</p> <p>The Program Manager Residential, who directly supervises residential/direct care staff makes unannounced, sporadic checks throughout the facility. The Residential Specialist also makes random checks throughout the facility. Through reviews of housing area logs, and interviews with staff and residents, it was confirmed that unannounced rounds are done randomly throughout the facility.</p> <p>Based on review of the policy, staffing plan and housing logs, and interviews with the Program Directors, Centre Inc. - Mandan meets the requirement of this standard,</p>

	<b>Auditor Discussion</b>
	<p>Centre Inc. Policy #P-17, Searches addresses the requirement of this standard. Centre Inc. - Mandan has a consistent practice of not conducting cross-gender strip, cross-gender visual body cavity searches, or cross-gender pat downs of residents which was confirmed through interviews with multiple residents, Residential Specialists, PREA Compliance Officer/Program Director and the Agency PREA Coordinator/Director of Operations. Pat searches are documented in resident logs in the SecurManage system.</p> <p>Policy was supported by practice as confirmed in the aforementioned interviews, and noted during the PREA audit tour. Staffs of the opposite gender "announces" themselves by gender when conducting checks of sleeping rooms and bathroom/shower areas. Policies are in place and staff appears very respectful in carrying out procedures which enable residents to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing their private areas of their bodies, except in exigent circumstances, or when such viewing is incidental to routine cell checks.</p> <p>Training records were reviewed and confirmed all staff received a two hour training entitled, "Searches and Inspection", which also included notification and explanation of the updated procedure. The New Employee Orientation Checklist serves as documentation that each employee is trained on pat- down searches. Centre Inc. policy clearly states the facility will not search or physically examine a trans-gender or inter-sex resident for the sole purpose of determining the resident's genital status.</p> <p>Based on review of policy, training documents, observation during the tour and interviews with staff and residents, Centre Inc. -Mandan is compliant with this standard.</p>

	<b>Auditor Discussion</b>
	<p>Centre Inc. Policy #P-18 Sexual Abuse/Assault Prevention and Intervention addresses the requirement of this standard. Centre Inc. - Mandan has established procedures to provide for residents that are limited English proficiency, residents with disabilities and residents with low literary levels equal opportunity to participate in and benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment.</p> <p>The agency policy prohibits the use of resident interpreters or other types of resident assistants except in limited circumstances where there may be delay in obtaining an effective interpreter. This is evidenced by current policy and procedure. Interviews with the Agency PREA Coordinator/Director of Operations, PREA Compliance Officer, and intake staff confirmed there has been no need to use an interpreter over this past year due to predominantly English speaking resident population. Centre Inc. - Mandan had a staff that recently left their employment that was bilingual and spoke Spanish. The facility staff is aware of community resources they can summon if the need for an interpreter were to arise. The Resident Specialist, who is conducting the intake, goes over information with the resident verbally and checks for understanding. The Residential Specialist will be able to provide immediate assistance to aid in the understanding of the written materials if a resident is in need because of a reading, comprehension, or hearing issue. The residents sign and date the document upon receipt, which indicates they understood the information presented. There were no limited English speaking residents at the facility during the e on-site audit visit.</p> <p>Based on a review of the policy and interviews with staff, Centre Inc. - Mandan is compliant with this standard.</p>

	<b>Auditor Discussion</b>
	<p>Centre Inc. Policy #PE-5 Personnel, addresses the requirement of this standard. The agency has established a system of conducting criminal background checks for new employees and contractors who have contact with residents to ensure they do not hire or promote anyone who may have contact with residents and does not enlist the services of any contractor who may have contact with residents who has engaged in sexual abuse in a prison, jail, lockup, community confinement facility, juvenile facility, or other institution, has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse or has been civilly or administratively adjudicated to have engaged in the activity described above. Centre Inc. considers any incidents of sexual harassment in determining whether to hire or promote anyone or to enlist the services of any contractor who may have contact with residents. Consistent with federal, state, and local law, Centre Inc. makes its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse.</p> <p>Centre Inc. asks all applicants and employees who may have contact with residents directly about previous misconduct described above in written applications or interviews for hiring or promotions and in any interviews or written self-evaluations conducted as part of reviews of current employees. Centre Inc. also imposes upon employees a continuing affirmative duty to disclose any such misconduct. Material omissions regarding such misconduct, or the provision of materially false information, are grounds for termination. Centre Inc. conducts criminal background records checks at least every five years of current employees and contractors who may have contact with residents.</p> <p>Through interviews with the Human Resource Generalist and PREA Coordinator it was determined that the agency policy and PREA standards were being followed concerning hiring, promotional decisions, and background checks, as such Centre Inc. - Mandan is compliant with this standard.</p>

	<b>Auditor Discussion</b>
	<p>Non-Applicable. Centre Inc. - Mandan has an adequate but older video and monitoring system in place. Since August 20, 2012 there have not been any significant upgrades to the facility, including technologies. The auditor suggested a camera be added to the kitchen. Per an interview with the Agency Head, they have plans to add additional cameras (including the kitchen) and update the existing cameras and video monitoring system in the next budget period. The agency considered how the updated system will enhance the agency's ability to protect residents from sexual abuse.</p>

The policy directs that all allegations of sexual abuse and sexual harassment be investigated and documented. The policy contains protocols for obtaining and preserving physical evidence. Interviews with the Agency PREA Coordinator/Director of Operations, and the PREA Compliance Officer/Program Director support practice as outlined in Centre Inc. Policy #P-18. The Facility ensures allegations of sexual abuse are referred for investigation to the Mandan Police Department unless the allegation does not involve potentially criminal behavior. If the allegation does not involve potentially criminal behavior, Centre Inc. will conduct an administrative investigation.</p> <p>The policy includes an overall description of the responsibilities and at what point a criminal investigation referral is made. A Memorandum of Understanding with the Mandan Police Department which indicates the Mandan Police Department utilizes protocol based on the Department of Justice's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents" is also posted on Centre Inc's website.</p> <p>Emergency medical healthcare along with forensic examinations by SANE/SAFE staff are provided at an outside facility, with no cost to the residents. An advocate will be provided to the resident upon request to provide emotional support through the forensic medical examination and investigation interviews. There were no forensic medical exams performed by SANE/SAFE staff during the last twelve months. Staff was able to articulate required PREA training components and offer examples of day to day implementation during multiple interviews. A review of training records was completed as part of the audit process. This objective screening tool is scored utilizing a scoring manual, entitled, the PREA Rating Assessment Manual, and will promote scoring consistency across ND facilities. Case Managers will be reminded, via a task due in the Case Management tab of SecurManage, within 25 days of the client's entry to complete the PREA Risk Re-assessment. The creation of this objective screening tool, creating parallel policy and procedures, which included the process of reassessing all residents within 30 days of the residents's arrival at the facility.</p> <p>The housing and program assignments are made on a case by case basis based on information obtained during the screening interview. The housing and program assignments may be changed after the inmate is further evaluated by the appropriate staff. Neither Centre Inc. nor the Mandan Police require a resident who alleges sexual abuse to submit to a polygraph examination or other truth-telling device as a condition for proceeding with the investigation of such an allegation. Investigators complete a written report with investigation findings that contains a thorough description of physical, testimonial, and documentary evidence.</p> <p>There were no substantiated allegations of sexual abuse that were referred for criminal prosecution in the past twelve months. The Investigation files reviewed were properly documented and organized.
